As additional consideration for the table(s) made available to me and intending to be legally bound hereby; I expressly waive all claims of any kind, including bailment, against the Pennsylvania Gun Collectors Association and the Pittsburgh Mills and their agents, servants, work men, employees, officers, officials and any co-tenant, lessor or owner and their respective officers, members, partners, corporate affiliates, agents, subcontractors, committees and representatives for any mishap, injury or loss occurring before, during or after the Pennsylvania Gun Collectors Assoc. show. I agree to have no loaded firearms in the show and make all firearms inoperable by use of a plastic wire tie or external trigger lock and remove all magazines. I agree to encase or tie down all firearms. I agree that all firearm transactions will be completed as required by all applicable local, state and federal laws. - No loaded firearms in the show except LE and PGCA security.
- All federal, state and local laws must be obeyed.
- All PGCA safety rules and rules of safe gun handling must be obeyed.
- All magazines must be removed from applicable firearms.
- Tie downs or secured display cases are mandatory for all firearms.
- All guns must be made inoperable by wire tie or lock.
- Cameras in show prohibited unless approved by the PGCA.
- Dealing in parking or atrium areas is prohibited.
- Walkie -talkies and alcoholic beverages prohibited.
- Tables not claimed by 8 AM Saturday revert to PGCA.
- Cancellations must be received 10 days prior to show date for refund.
- \$15 fee for all returned checks.
- No table reservations accepted without payment or PGCA approval.
- Exhibitor or member badges must be displayed at all times.
- Any conduct deemed detrimental to the good order, safety and operation of the show will result in expulsion.
- Exhibitors will receive one exhibitor badge for their sole use and one helper's badge. Additional helper's badges available at \$7 each.
- Helpers are not permitted to shop or purchase during set-up hours.
- PGCA members admitted free. Public admitted for \$7 donation per day.
- The President and Show Chairman have the final & exclusive decision as to table placement & assignment.
- Exhibitors are responsible for the clean up & good order of their table area.
- Tables must be maintained until **4 PM Sat. & 3 PM Sun.** unless approved by PGCA.
- Issued "OK to RELEASE" tags must be attached to all sold firearms.
